- Life insurance policy
- Financial accounts at your bank, brokerage account, and CDs

**LIFE INCOME GIFTS** include charitable gift annuities or charitable remainder trusts and represent donations of cash or securities in exchange for an ongoing source of income, and a charitable income tax deduction.
